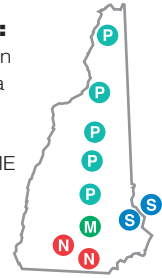

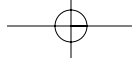

CREDIT AGREEMENT

Customers with account balances more than thirty (30) days overdue will be placed on COD and no discounts will be allowed on purchases until all outstanding balances are paid in full. Failure to pay account balances in a timely fashion could result in revocation of credit purchase privileges at the seller's discretion. Notwithstanding the use of this joint credit application, the undersigned applicant acknowledges that each of the four companies listed above is a legally distinct entity, separate from the other entities.

IN THE EVENT THAT THE INDEBTEDNESS IS NOT PAID AS SET FORTH HEREIN, THE UNDERSIGNED AGREES TO PAY A SERVICE CHARGE OF ONE AND ONE-HALF PERCENT (1 1/2%) PER MONTH (18% PER ANNUM) SIMPLE INTEREST ON THE UNPAID DELINQUENT BALANCE.

The undersigned agrees to pay all costs for reprocessing checks for insufficient funds and in the event that the account of the undersigned is placed for collection, the undersigned agrees to pay all costs of collection including, but not limited to, reasonable attorney's fees and court fees, incurred by the company or companies from which product was purchased.

Should the applicant change its legal entity from that indicated above or should the applicant's ownership be changed in any fashion, the undersigned agrees to promptly notify the above listed companies of the change in writing.
